Rogers and enter Officers' Club and Mess Mumber Two, Building T-930, Freeman Field, Seymour, Indiana, after the said First Lieutenant Joseph D. Rogers, acting in his capacity as Assistant Base Provost Marshal, had ordered them not to enter said building.
